Kindly refer to our letter dated 09.05.2013 on the subject cited above. In this connection we would like to inform that we have received two representations, one from the relative of Mr. Z.A. Siddiqui working as SA to DGM, EM (Central), Kidwai Bhawan, New Delhi, who is in hospital since 20.04.2013 for Stomach cancer treatment and second from Sh. Umesh Dutt Sharma, working as SDE (MM) Corporate Office, New Delhi and an estimate of Rs. 9.00 lakh from Medanta Hospital has been given to the TPA. It may kindly be noted that Sh. U.D.Sharma is scheduled to be admitted on 15.05.2013 for Hepatitis-B related chronic Liver Disease (Photocopy enclosed for ready reference). But these cases are not being processed under floater scheme of MTNL.by TPA.

It is informed by the relatives of Mr Siddiqui that representative of TPA (M/S E-Meditek) informed that Mr M.K.Saxena, DGM (HR) Corporate Office, MTNL has directed the TPA in a meeting that the cashless treatment should not be provided to any employee except for death cases or accidental cases.

Keeping in view, the above mentioned circumstances, it is once again requested to kindly process the cases under floater/cashless scheme for both the employees as per the requirement of Hospital so as to provide them effective medical treatment at this crucial stage.
