DEMANDS

5. Implementation of the assurance given by Govt, of India for Payment of Pension & Pensionary benefits to all the employees absorbed in MTNL on par with BSNL without further delay.
6. Revision of pension and family pension from time to time to the retirees of the DOT Employees absorbed in MTNL & who have opted for the Govt. pension as is happening to Central Govt. Pensioners. The pension & family pension have not yet been revised w.e.f. 01/01/2007 for those who retired prior to 31/12/2006.
