 - a. No Disciplinary / Vigilance case is pending against the Officer or Vigilance Clearance is withheld in terms of instructions contained in GOI (DoP&T) OM No. 22011/4/91-Estt. (A) dated September 14, 1992.
 - b. Currency of penalty, if any, against the Officer(s) is over.
 - c. The Officer has been permanently absorbed in MTNL.
- 3. The promotion shall be effected w.e.f. 11/04/2013. However actual financial benefits may be accorded with effect from the date the officers assume charge in the grade of Sr. Manager(Telecom). The promoted officers, incase of officiating in the grade of Sr. Mgr.(Tele.) on Adhoc/local arrangement, may be reverted for a day break before implementing this order.
