The Corporate Management of MTNL can not and should not pretend to be ignorant of what is happening in MTNL, Delhi Unit. With the tacit support from none other than the Head of the Delhi Unit, there are systematic and concerted attacks to wreck up the Finance and Accounts Wing.

There is an age old practice to maintain a fine tuning balance so that the efficient and righteous functionaries of Accounts & Finance Wing do not come under the line of fire of the overzealous engineering executives who sometimes erroneously conclude that Finance Wing is nothing but a "nuisance". But in MTNL, Delhi Unit, this practice has been demolished by the Administrative Units.

This trend forms an ugly proportion consequent upon the officers of Accounts & Finance Services Group "A" opted for absorption in MTNL much to the displeasure of ITS Group "A" officers, who decided not to opt for absorption. either in MTNL or BSNL.

To substantiate the above observations, we may refer various example of transfer and postings of the officers of Accounts and Finance wing effected by the administrative unit, MTNL, Delhi. It appears that the Head of MTNL, Delhi Unit is using the rotational transfer issue as a stick to beat the finance wing, for this the unit of GM (Admn) is instrumental. Important functionaries of finance units who are working with due satisfaction of functional heads of finance units are being transferred out violating the norms and with pick and choose policy. The functional heads are not only ignored but conspicuously rebuffed also in the process.

The series of official interactions, exchange of notes, correspondences on record will bring home the truth. How can and how long MTNL Corporate Office will play a role of silent spectator when its subordinate unit is burning with "CIVIL WAR" like situation ?
