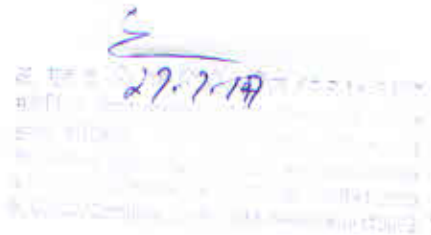

**Subject :- Denial of Regular Promotion as AO from actual date of promotion i.e. 20.02.2013-
Case of Smt. Sadhana Saxena (Staff No. AC-15315) AO (TR) NP-1.**

Sir,

Kindly recall our discussion held with your goodself in various meetings regarding the subject under reference. We are once again submitting the brief history of the case for your kind and sympathetic consideration :-

1. The Official was promoted as Accounts Officer on regular basis w.e.f. 20.02.2013 vide Corporate Office order No. MTNL/CO/Pers.II/Prom.A.O.(E-3)/2012-2013/555 dated 10.04.2013 & Sr.Manager Admn.IHQ Order No. STA-1-22/Tfr & Pstg/AO/2013/Pt-1/19 dated 19.06.2013 in the scale of Rs. 24900-50500 and posted at Corporate Office.
2. Due to shortage in the area, the official could not be relieved to join her posting in Corporate Office and her case was sent for retention in the area to the administration.
3. The official was working as Accounts Officer (LA) in the area and could not join her new regular post on promotion within 40 days as stipulated in the order as she was not relieved by the area administration.
4. Subsequently revised orders were issued by Corporate Office vide letter No. MTNL/CO/Pers.II/Prom.AO(E-3)/2012-13/810 dated 11.02.2014 and HQ letter No. STA-1/1-22/Tfr & Pstg/AO/2013/Pt-1/34 dated 11.03.2014 with the instruction to assume the charge as AO on regular basis in the same unit prospectively.

Sir, all the executives have joined their duty w.e.f 20.02.2013 as they were working in the same units except the executives placed at Sl. No. 6 &7 who have been posted on promotion as AO in Corporate Office. It happened so as these two officials were not relieved by their respective controlling units. Hence the conditions of 40 days can not be made applicable in this case.

In view of the above mentioned circumstances, it is requested to kindly reconsider her case and her promotion may be made effective w.e.f. 20.02.2013 the date from which all the officers have got the promotion instead of prospective dated i.e. 11.02.2014 as the officers were already performing the duties of AO in the scale of Rs. 24900-50500 (E-3).
