**Sub: Promotion and posting of the Executives from the grade of SDE to the grade of DE on purely temporary and adhoc basis.**

1. The 58 Executives, as named in the enclosed Annexure, are hereby promoted from the grade of SDE (Telecom) to the grade of DE on purely temporary and adhoc basis w.e.f. 13.08.2008 until further Orders and posted to the Units as shown against their name(s).
2. These Officers promoted on adhoc basis are liable to be reverted to their substantive grade at any time without assigning any reason and prior notice by the Management on account of any administrative reasons.
3. The promoted Officers will have no right to claim for regular appointment in the promoted grade. Services rendered in the promoted grade shall not count for the purpose of seniority in the grade of DE. Their seniority will be determined with reference to their basic seniority in the substantive grade of SDE (TES Group B).
4. The Officers, incase, officiating in the grade of DE on local officiating arrangement may be reverted on or before 13.08.2008 before implementing this Order.
5. The Officers shall not be promoted to the higher grade by the concerned Units in case:
  - i. Disciplinary / vigilance case is pending.
  - ii. The Officer is under the currency of any penalty
  - iii. P.O. not issued due to any reason.
  - iv. If the Seniority No. or the Category is different than the indicated.
  - v. Ad-hoc Promotion Orders already issued by DOT/MTNL.
  - vi. Due to any direction from Hon'ble Court/CAT for not effecting the promotion to an individual.


All cases covered under the above clauses may be forwarded within 15 days from the date of issue of this Order to this office for taking appropriate action.

6. The representation regarding non inclusion of the name of any of the Officer senior to those included in the Annexure may be forwarded to this office along with Screening Report (for the year 2001-02 to 2005-06), Vigilance clearance and recommendation of the Competent Authority within 15 days for taking appropriate action.
7. In accordance with the instructions contained in DOT Office Circular No. 12/75/2000-STG.I dated 18/8/2000, the Officers are required to join their promotional assignment within a time period of 40 (forty) days. The ED concerned may ensure that the station of posting Orders in respect of the Officers are issued in time and such Officer is relieved accordingly so as to enable him to join the assignment within a prescribed time period of 40 days from the date of issue of this Order. In case the Officer concerned fails to join the promotional assignment within the prescribed time period of 40 days, he should not be allowed to be relieved or join the post thereafter. In such an event the promotion order shall become imperitive and the matter shall be reported to this office for further necessary action. Further no request for modification of promotion/posting Orders shall be entertained after the expiry of the 40 (forty) days period.
8. Leave, if any, requested by the Officer(s), who has been posted on promotion to a different Office, should not be allowed. If any Officer desires leave, he/she can apply for leave to the new Controlling Officer only after joining the new post and the new Controlling Officer will sanction leave, if it is considered justified in normal course.
9. The date on which the above Order is given effect to may be intimated and charge-reports sent to all concerned. A consolidated list of the Officers who have been relieved / joined their new postings may also be sent immediately on completion of 40 days from the date of issue of this Order.
10. This is further subject to outcome of the judgments of Hon'ble Courts in the cases pending therein.
11. This issues with the approval of Competent Authority.
