Sub: Group Health Insurance Policy for MTNL Working Employees- Regarding extension of Scheme from 10.06.2015 to 09.06.2016.





Sub: Group Health Insurance Policy for MTNL Working Employees- Regarding extension of Scheme from 10.03.2014 to 09.03.2015.

This is in continuation of this office circular no. MTNL/CO/Pers/W.E.-GHIS (Renewal)/2012/124 dated 8th March 2013. As per approval of Competent Authority, it has been decided to extend the Working Employees Group Health Insurance Scheme for one more year from 10.03.2014 to 09.03.2015. The Indoor part of the Scheme will be managed through an Insurance Policy which will be served by M/s United India Insurance Co. Ltd through following two different TPA's in Delhi and Mumbai.

For Delhi- M/s E-Meditek TPA & M/s Vipul MedCorp TPA
For Mumbai- M/s Raksha TPA & M/s Paramount TPA

The Scheme shall take effect from 10.03.2014 for a period of one year.

There shall be following changes in the policy w.e.f. 10.03.2014

1. In case of major illness the capping of 80% is enhanced to 100% of the sum insured i.e. Rs. Two Lacs.
2. Corporate Floater Facility is replaced by Super Top Up Facility under which the TPAs shall directly settle the Major Illness cases upto Rs. Four Lacs beyond the sum insured of Rs. Two Lacs on family floater basis. The following diseases/ procedures shall be covered under the Major Illness category-
Major illness – angioplasty, cardiac surgeries, cancer surgeries including chemotherapy, brain tumor surgeries, pacemaker implantation for sick/sinus syndrome, hip replacement and joint replacement, Kidney related diseases including dialysis and kidney transplant. Any other such diseases which is prolonged due to complications where hospitalization is for seven days or more.
3. Any two dependent children of the employee shall be covered however family size of 06 members shall remain the same.

Other terms and conditions of our office circular no. MTNL/CO/Pers/Med. Ins./W.E./2011/622 dated 09th March 2011 & MTNL/CO/Pers/WE-GHIS/2011/Vol. II/741 dated 09.03.12 shall remain the same.

Any further information in this regard may be had from the concerned GM (Admn) Office in Delhi and Mumbai / GM (HR) in C.O. or from the day time Help Desks provided by the TPA(s) for the benefit of the employees.
