Sir,

You must be aware that there is no marked progress in DOT/Govt. in respect the issue mentioned above since 26.11.2010 - the day we postponed the Protest Actions despite very categorical assurance from you that "both MTNL management and DOT will continue to pursue the case actively".

During this period some of our associates met various DOT officials including Member (Services). The impression that they could gather from such informal interactions is far from encouraging so far as the settlement of the above mentioned issue is concerned.

It is also learnt that MTNL has been asked long before to provide details

of the Pension contributions to DOT as well as payment of pension to the retirees that MTNL has paid since 1986 but MTNL has not yet provided that to DOT. If it is true, it does not go well with your above said assurance.

We would request you to kindly ensure that this important issue is dealt with due sincerety and seriousness.
