You are aware that 3rd. PRC is expected to be constituted soon. It is now a pressing need for MTNL employees and retirees the implementation of pay fixation @78.2% basis as on 1.1.2007. If it is not done now, it will be an irreversible loss.

Likewise, the issues like providing a fresh pension opportunity to pro-rata pensioners of MTNL in the background of the pension on combined services of MTNL pensioners having been taken over by DOT, as well as providing medical facilities under CGHS to the MTNL employees,- still working and since retired, are very burning issues for all of us in MTNL.

All these issues have been taken up with DOT/MTNL since long and constantly pursued but to no avail so far. We in this United Forum is now seriously considering to launch **DEMONSTRATIVE ACTIONS** to convey our protest against the denial of these issues and press for immediate settlement.

We are aware that your organization is also equally exercised over these issues. We would, therefore, request you to kindly think over organizing this movement unitedly. We sincerely feel, this is a crying need of the hour, in the interest of MTNL employees and retirees.
