First of all GM(NP) welcomed all the Association Representives. He expressed need for proper working and action-oriented management.

Thereafter, points in the agenda were discussed one by one as per following details:

### Shortage of man-power and material:

Association representatives raised the issue that SDOPs and DEs are being pressurised for getting the work done , inspite of the fact that there is shortage of TSF kits especially TSF-7 kits are not available.

GM(NP) informed them that all kits except TSF-7 are available and TSF-7 kits will be made available by the 3rd week of August.

Regarding shortage of manpower, GM(NP) told that the tender in regards for arrangement of labour is likely to open on 04.08.2016 by MM Unit.

Association raised the points of Tarpoline and suggested that purchasing should be done centrally by Task Force through limited tender. GM(NP) also clarified that this process takes time and may take 2-3 months to mature.

Association raised the point of not providing vehicles to SDE(Cables) especially in NP area for that GM(NP) instructed AM(NP) to provide vehicles to SDE(Cables) between 11.00 a.m. to 12.30 pm positively, which has also been made functional. The same is to be implemented in other AM areas.

Regarding posting of regular DEs , Association raised the technical issue in completing CR of officers on seniority basis. GM(NP) assured that posting will be done shortly.
