Minutes of the Introductory Meeting of CMD MTNL with the representatives of MTNL Union and Associations, New Delhi.

Sh N K Yadav; Member(Services), DoT on taking over the charge of CMD, MTNL, held an introduction meeting with the key representatives of MTNL Mazdoor Sangh(Majority Union, Delhi), MTNL Executive Association, CHQ, MTNL Senior Executive Association and TEAM on 08/06/2015 at 05.00 PM.

Director(HR) welcomed Sh N K Yadav, CMD MTNL and participants of the meeting.


CMD, MTNL in his address emphasized that the expenditure of MTNL is higher than its revenue resulting in poor financial position of the Company. The revenue of MTNL needs to be increased for making MTNL into a profitable Organization. The main focus of MTNL should be to extract more revenue from data services(Broadband) by providing fast and uninterrupted services to our esteemed customers.

MTNL should increase the Broadband connections by converting existing landline connections into Broadband connections. The quality and speed of Broadband connections will be increased with the existing cable network by reducing the length of Cable and replacing the dropwire with twisted pair cable for Broadband connection. Further, by installation of DSLAM at BTS sites, MTNL office buildings, pillar/cabinets and in the high rise societies, this objective can be realized early.

CMD MTNL requested the Union's and Association's representatives to pass on this message to other employees in the Units and to extend their support to bring in this transformation.

The meeting ended with Director(HR) thanking all the representatives of Majority Union and Associations for their participation in the meeting.
