Subject :- Non-payment of salary to MTNL employees.

Respected Madam / Sir,
MTNL employees are not getting salary regularly since November, 2018. The salary for the month of January, 2019 has been paid only on 21/02/2019. The salary for the month of Feb, 2019 has not been paid even today. There is no indication when Feb, 2019 salary will be paid. The top management of MTNL is clue less about the prospect of payment of salary.

Kindly refer to the letter No. UFOM(D&M).2014 -19 dated 05/02/2019 of United Forum of MTNL Unions & Associations to which this association is affiliated. It is explained therein about the hardship of the employees due to non-payment of salary on due date. But no relief is provided and the situation is turning bad to worse.

DOT / MTNL .have not considered our suggestions to improve upon the conditions of MTNL and bring back it on to the revival trajectory.

It appears that MTNL and its employees have been abandoned on the slippery slope of gradual decay and destruction.

In view of this, it is already demanded that DOT should come forward for total rescue of the employees of MTNL , the vast majority of which are erstwhile DOT employees. Let them be allowed to repatriate back to DOT and DOT can go for their redeployment elsewhere
