2. Implementation of 3<sup>rd</sup> PRC
3. Immediate neutralization of 78.2% IDA w.e.f. 01.01.2007 at par with BSNL on actual basis
4. No reduction of retirement age from 60 to 50 years
5. Immediate revival of MTNL by merging MTNL with BSNL and award 4G / 5G to MTNL / BSNL
