Sir,

Kindly refer to our letter dated 19/11/2014 as stated under reference above. We pointed out some specific instances of discrepancies/irregularities in the recruitment of senior Management Trainee in MTNL under the advertisement No. MTNL/SMT/2011 and solicited investigation by the appropriate vigilance/investigating authorities. Even though we pointed out quite a few specific instances where rules were flouted/violated to suit favoritism, nepotism and pick and choice sort of irregularities, we informed that there are strong indications that the irregularities and violation of rules are more deep rooted and wide spread in this case.

- 2. To our utter dismay, we did not find any response from your office in this respect. As per our information, MTNL Corporate Office and its HR Unit has preferred to ignore the said letter and remain to sit over the alleged irregularities which are little short of corruptions.
- 3. For ready reference, we enclose herewith the copy of the said letter and enclosed supporting documents once again with a hope that you will take appropriate actions in this respect.
- 4. We sincerely hope, at least this time you will not ignore this issue and take prompt action in this respect. But if it is not so done, we shall not be left with no other alternative but to resort to

other legitimate and appropriate means in the interest of finding the truth and enforcing the transparency in the recruitment etc so that the rights and interests of the genuine eligible candidates are protected.

5. Pending investigation as suggested by us, this selection should not given effect to.
