Sub:- Ambiguity in Paper -V(Service Rules)of Main JAO Examination held on 30-11 08.

I would like to bring to your kind notice some ambiguity observed in the question paper-V (Service Rules) of main JAO's examination held on 30.11 2008. The ambiguities observed are as under:-

- In Question No. 1 which was compulsory, the rate of Dearness Allowance
 has not been given for calculation the retirement gratuity amount. In the
 absence of DA Rates, candidates could not work out retirement gratuity
 amount properly.
- In question no. 2 for pay fixation, the basic pay given as 18300/- in the scale
 of Rs. 16000-400-20800 whereas the stage of Rs.18300/- is not available in
 the given scale and due to this ambiguity candidates could not fix the pay
 properly.
- Question No. 5 (b) relating to Foreign Service was out of syllabus with respect to the clarification given by Corporate Office vide their letter No. MTNL/Pers/CO/R&E/1(110) 2007/1/1029 dated 21.10.2008 and may be referred to.
- 4. In question No6 (b) number of Earned Leave at credit on superannuation have not been given and candidates work out the leave encashment by assuming /presuming the days at credit on superannuation. Whatever the answers given by the candidates by assuming/presuming the number of days at credit of Earned Leave may kindly be treated as correct.

In view of the above ambiguities in the paper No. V (Service Rules) suitable instructions may please be given to the examiner that while valuating the answer sheet the ambiguity mentioned above may be kept in mind for awarding suitable marks to these questions.

It is further added that suitable grace marks may be given to all the candidates for question No.5 (b) which was out of syllabus.
