We were compelled to extend the **PROTEST ACTIONS** further as there is no move on the part of DOT/MTNL to solve the issues amicably. Rather the status report sent to us vide No. MTNLCorporateNo.MTNL/CO/IRW/21(135)/2012/part/869 dated 13/07/2017 in response to our earlier Notice dated 28/06/2017, indicates that MTNL is inclined to suggest certain rider to be put in the implementation of 3rd PRC recommendations in the revision of pay scales of MTNL employees isolately. In this matter our stand has been clarified in our written response to this status report. Let there be no mistake in the matter of our demand for FULL PAY REVISION and PENSION REVISION. The response in respect of other matters including the issue of Merger of 50% DA with pay as on 01/01/2007 effectively amounting to 78.2% is far from satisfaction of MTNL employees and pensioners.




