Sub: Wrong fixation of Seniority in JTO cadre.

Sir,

Kindly refer to letter No. Exam /JTO 15% /99/ dated 24.06 2003 and 3<sup>rd</sup> July, 2003 (Photocopy enclosed) vide which additional result of Departmental Competitive Examination held on 15<sup>th</sup> and 16<sup>th</sup> of May 1999 was declared with relaxed standards for promotion to the cadre of JTO 15 % (Quota). These officials were deputed to look after the work of JTO on local arrangement basis without extra remuneration vide letter no. STA-1/2-7/Ind.Trg/JTO's/2003/155 dated 11.08.2004 and posted as JTO on regular basis from the date of completion of 1st phase Trg. W.e.f. 27.01.2004. As per letter of even number dated 24<sup>th</sup> June, 2003 these candidates declared qualified with relaxed standards will stand en block junior to those, who have already been working as JTO but are yet to be absorbed in MTNL and those who might have been absorbed in Group 'C' but subsequently have been trained and posted as JTO.

It is reliable learnt that some candidates declared qualified for promotion to the post of JTO under 35 % quota vide letter no. Exam /JTO(35 %)/ Result/2000 dated 10<sup>th</sup> July,2000 and joined as JTO during 2002 after completion of 1st Phase Training were made junior to these candidates who joined w.e.f. 27.01.2004 and their seniority has been fixed in between the JTO joined during 2002.

It is therefore requested to kindly re-examine the issue of fixation of seniority of these two batches and placed all the 32 JTO's en-bloc junior who joined as JTO w.e.f. 27.01.2004 to those JTO who joined during 2002 .
