Kindly refer our earlier letters cited under reference stating that simply by cancelling the results of the written test MTNL Corporate Office can not wash off its hands. Right from the beginning, our Association was pointing out that fraudulent activities being resorted to. HR Section was bent upon to give credence to this fraudulent process and even went up to Hon'ble court of Law and published the results. The position of HR Section became untenable when a number of frauds were categorically established. Then only the process was terminated.
