Subject: Disbursement of pension and pensionary benefits to all combined service optees of MTNL pensioners.

While processing the pension cases and distribution of Government PPOs to the MTNL CSO pensioners, this office is facing a lot of difficulties due to mis-match of names of the pensioners amongst PPO book, PAN Card and Aadhar Card. As per Department of Expenditure letter dated 14.11.2014, the Aadhar based life certificate issued online by Jeewan Praman System through the Government Agencies shall also be acceptable. It has been further learnt that Aadhar Card is going to be made mandatory by the Central Government for Central Government Pensioners. And PAN card is necessary for Income Tax matters.

Instances of mis-match of name has been categorized as under:

- (i) Name of pensioner in the PPO differs from the name appearing in PAN Card and Aadhar Card both.
- (ii) Name of pensioner in PPO differs from the name appearing in Aadhar Card or PAN card only.


Considering the plight of the old pensioners, it has been decided to hand over the photocopy of the PPO to the pensioners after obtaining an undertaking that he/she will submit the corrected copy of Aadhar card/PAN card within two months otherwise his/her pension will be stopped till the receipt/submission of corrected documents. A format of the undertaking is also attached herewith.

In addition to above, it has been also observed that, in some cases the name appearing in the Government PPO does not match with the name appearing in service records provided by the pensioners which requires immediate action for correction of this discrepancy in the service records as well as Government PPOs, if required.

You are therefore, requested to look into the matter of such cases and arrange to issue necessary instructions to the concerned Pension Sanction Authority to correct the discrepancy in the name wherever required so that all the service records hold the same name of the pensioner.

This issue with the approval of the competent authority.
