We raised following DEMANDS long before. This United Forum and some of its associated unions and associations made representations to resolve these issues; But none of these issues has been settled so far.



DEMANDS

- 78.2% neutralization at the pay fixation as on 1.1.2007 as per wage commission report.
- Payment of arrears of pension w.e.f. 1.1.2007 (@68.8% neutralization basis) to the retirees entitled for combined pension..
- Providing a fresh opportunity for exercising pension option to the Pro-rata pension holders in MTNL.
- Extending benefit of medical facilities under CGHS to all sections of absorbees - working or since retired.

We have provided the justifications on previous occasions and latest by our correspondence of even number dated 17/05/2014.

The purpose of this letter is to remind your goodself about these long pending issues with the expectation that MTNL/DOT would now take immediate actions to resolve these issues.
