## Subject:- Revival of MTNL

Sir.

We all are well aware that Govt. of India has ultimately decided to revive MTNL by bringing it under the broad umbrella of BSNL in form of latter's subsidiary entity to start with & ultimately getting merged with BSNL completely after completing certain essential paraphernalia required to cop up with the present status of MTNL as a listed company vis-a-vis BSNL being 100% owned by Govt. of India.

Further, MTNL Employees are also well aware that Govt, has decided inter- alia, to arrange some financial package & offer 4G spectrum for revival of MTNL/BSNL to bring them to a viable operational stage.

- 1. It cannot be ruled out that MTNL is now suffering drastic cascading effects of dysfunctional consequences of multiple responsible factors like superannuated network & technology, cut throat competition in telecom tariff & quality of service & ultimately incredible depression in MTNL revenue thereby putting MTNL into unprecedented loss.
- Our submission is that prompt & adequate provision of financial back up & 4G/5G Spectrum needed to keep MTNL afloat may be made till merger with BSNL will take place.

- 3. The process of merger of MTNL with BSNL may be expedited at earliest so that further revenue loss of both the entities may be plugged to bring them to operationally viable stage as leading telecom service provider in telecom service sector.
- The revival of MTNL cannot be considered in isolation i.e. MTNL cannot be truly revived ignoring interest of MTNL executives. So keeping them in high moral & motivational spirit, their carrier progression & beneficial claims should be taken care of.

Our sincere desire is that MTNL/BSNL should be efficient, competitive, & financially viable. we are definitely aware of importance of the roll of the employees in this respect, we assure your good self of our sincere commitment for that.

We once again request your good offices to expedite the process of revival of MTNL taking into

account all the factors stated above.
