- (d.) The services so rendered in DGM grade will not be counted for the seniority in the Grade or for any other further promotion from the Grade and consequential benefits.
- (e.) This arrangement shall stand terminated from the date of the approval and notification of the promotion policy or date of absorption of Group "A" Officers working on deemed deputation whichever is earlier and/or at any earlier substantive posts at any date without any notice. Further they are liable to be reverted to their substantive post at any date without any notice.
- (f.) If any Disc./Vig. Case is pending or punishments like stoppage of increments etc. is current against any of the officer the fact should be reported to this office and the Officer should not be allowed to look after the charge of DGM.
- (g.) This arrangement shall however be subject to the final outcome of the related pending Court Cases/OAs/TAs.
