No. 40-19/2000 -Pen(T) dated 21.11.2000 (Cc ly enclosed for ready reference)

- Certain doubts in this regard has been related with regard to payment of interest on gratuity, time for such interest is payable and whether separate Presidential Order needs to be Issued by Department of Communications for Group A & 8 officers of MTNL for pro-rate pension etc. Necessary clarifications in this regard are as indicated below:-
- The notification No. SO1821(E) dated 25.10.2007 issued by the Department of Pension and Pensioner's Welfare cames an explanatory memorandum that no one shall be adversely affected by giving retrospective effect to this notification ". As regards wherein it says that "This is certified payment of interest on gratuity, it is clarified that since Group A & 8 Officers of MTNL were desired to have been absorbed in that organization w.e.f. 01 10.2000, they will se completing seven years on 30.09.2007. relevant provisions ir this regard contained in DOP&PW OM No. 4/18/87-P&PW(D) dated 05.07 1989 are reproduce below:

Thus, the said notification applies to all Government employees irrespective of any Department no separate Presidentii | Order needs to be issued by for Group A & B optoes of MTNL for pension. The DOP&Pt / notification is statutory in character and does not need administrative approval of DOT Head Quarter
- In view of the position explained above, MTNL is requested to call for options for pro-rets pension in in the absorbed Group A & B. Officers after, giving them sufficient time, as deemed fit, for exercising the option to draw pro-rate pension.
